

PRE-1918 BRIEFS AND RECORDS COLLECTION IN THE UNIVERSITY OF SOUTH CAROLINA LAW LIBRARY

***Leroy F. Youmans Collection of Briefs and Records* (1858-1879):**

The *Leroy F. Youmans Collection of Briefs and Records* includes five bound volumes of a set called *Law Pamphlets* (Vols. 8-12). These volumes were bound by Youmans and are kept in the Legal History Room, catalogued at call number KF211. L28. The binding of volume 3 of the *Law Pamphlets* was in such poor shape that it was separated into individual sets of briefs and records and shelved with the unbound briefs and records at call number KFS1845.9 .P74. Several unbound pamphlets of briefs and records make up the remainder of the Youmans collection. The unbound briefs and records appear to have been at one time bound volumes in the Youmans Collection, but the bindings were destroyed by wear and tear to the point where they have fallen apart completely. There is no indication on the dilapidated bindings as to which volumes in the set they are. The Youmans Collection of briefs and records are housed in the South Carolina Legal History Room in order by the dates the cases were heard at the appellate level, at call number KFS1845.9 .P74.

***Mitchell & Smith Collection of Briefs and Records* (1878-1896):**

The *Mitchell & Smith Collection of Briefs and Records* is an 8 volume set containing briefs and records for cases in Federal and State Courts. This collection includes cases that range from 1878 to 1896. The bindings were crumbling and in some cases completely gone, so the briefs and records have been placed in pamphlet holders for preservation and are housed in the South Carolina Legal History Room in order by the dates in which they were heard in state and federal courts, at call number KFS1845.9 .P74.

***Hart & Hart Collection of Briefs and Records* (1880-1885):**

The *Hart & Hart Collection of Briefs and Records* is one bound volume with briefs and records for cases dating from 1880 to 1885. Due to the poor condition of the binding, these briefs have been separated and placed in individual pamphlet holders and are mixed in with the previous collections in order by the date they were heard by the S.C. State Supreme Court, at call number KFS1845.9 .P74.

***Benjamin Lindsey Abney Collection of Briefs and Records* (1878-1916):**

The *Benjamin Lindsey Abney Collection of Briefs and Records* was donated to the Law

Library, along with Abney's personal library, in 1923. Included in the donation was the *Southern Railway Company Collection of Briefs and Records* (1902-1916) and the *Southern Railway Company Collection of Miscellaneous Records*. Those two collections will be listed separately below. The *Abney Collection* consists of 25 bound volumes of briefs and records spanning from 1878 to 1916. Over the course of time, some of the volumes have been lost. The original set was numbered. The Law Library has Volumes 2, 4-11, 13-15, 18, 20, 23, 25, and 27. Volume 27 is titled *Seminole Securities Company Cases*. There is an unnumbered set with the title *State Dispensary Commission Cases*, which consists of 8 volumes. The numbered volumes and the 8 volume set have been separated from their crumbling bindings and the briefs and records for individual cases placed in pamphlet holders. They are housed in the South Carolina Legal History Room with the other briefs and records comprising the Pre-1918 Briefs and Records Collection at call number KFS1845.9 .P74.

***A. H. Dagnall Collection of Briefs and Records* (1903-1915):**

The *A. H. Dagnall Collection* consists of two bound volumes of briefs and records that are housed in the South Carolina Legal History Room at call number KFS1845.

***Butler & Osborne Collection of Briefs and Records* (1904-1907):**

The *Butler & Osborne Collection* consists of two bound volumes of briefs and records, volumes 2 and 3 of firms' collection, and are housed in the South Carolina Legal History Room at call number KFS1845.A2 S8. The volumes were purchased from a private book dealer in March and July respectively. The dealer bought them at an estate sale. There were apparently no other volumes from the original set for sale or he did not see them.

***Elliott & Herbert Collection of Briefs and Records* (1909-1910):**

The *Elliott & Herbert Collection* is a one bound volume of briefs and records that is listed as Vol. 4 on the spine. Volume 4 is the only volume of the set that the Law Library has in the collection. Due to its crumbling binding, individual cases in this volume have been placed in pamphlet holders and are housed in the South Carolina Legal History Room with the other briefs and records comprising the Pre-1918 Briefs and Records Collection at call number KFS1845.9 .P74.

***Southern Railway Company Collection of Briefs and Records* (1902-1916):**

The *Southern Railway Company Collection of Briefs and Records* consists of several bound volumes numbered 1 to 35 in a first series, with a second series of which the Law Library has only volume 8. The Law Library has in the first series, volumes 10, 14[?], 16-23, 26-28,

30-35. In the second series, the Law Library has only volume 8. These volumes are housed in the South Carolina Legal History Room at the end of the Pre-1918 Briefs and Records Collection at call number KFS1845.9 .S683

Southern Railway Company Collection of Miscellaneous Records (1882-1906):

The *Southern Railway Company Collection of Miscellaneous Records* consists of three volumes. The first volume is Volume 12 of the set, *Circular Letters of the Southern Railway and Steamship Association, 1882-1883*. The second volume is labeled as volume 2 of the set *Southern Railway Company Miscellany*. The third volume is labeled as volume 4 of the set *Southern Railway Company Miscellany*. The second and third volumes have miscellaneous pamphlets of Southern Railway Company documents, speeches of the company's officers, and briefs and records of court cases involving the company. The two *Southern Railway Company Miscellany* are housed in the South Carolina Legal History Room at call number KFS1845.9 .M58, while the *Circular Letters of the Southern Railway and Steamship Association, 1882-1883* is housed in the South Carolina Legal History Room at call number HE2761 S68.
